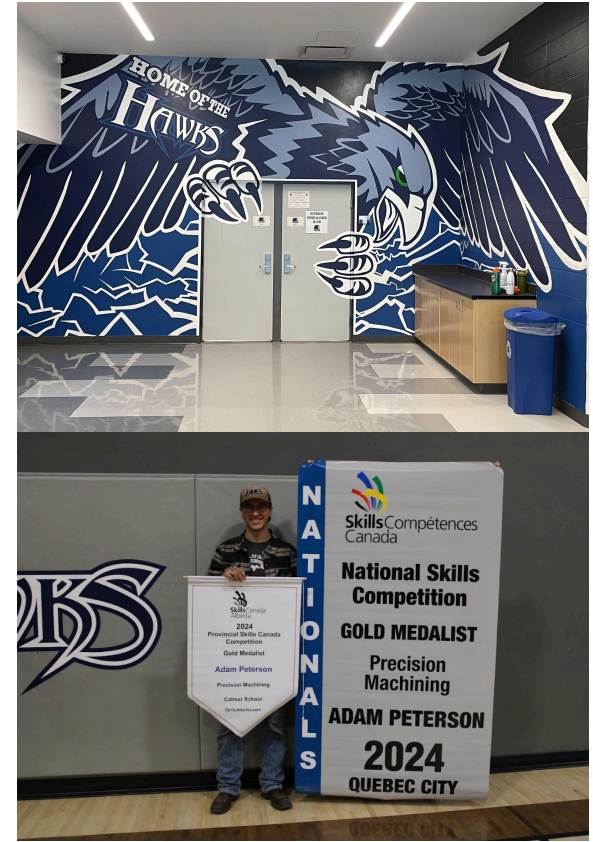

CALMAR SECONDARY SCHOOL



School Profile:

Calmar Secondary School is a grade 7 – 12 school located in the town of Calmar, Alberta, and adjacent to Calmar Elementary School. It is in the Black Gold School Division. Calmar is 20 kilometers west of the city of Leduc and approximately 40 km. Southwest of the city of Edmonton. The school houses approximately 260 students and 26 staff with 14 FTE teachers. Calmar is currently in the process of transitioning into a Collegiate school and as part of that change a shop intended to house Carpentry, Electrical, and Pipe Trades training is being added to the front of the school. Collegiate schools exist within the Alberta Government mandate of career pathways, postsecondary connection and individualized student support. This transition will eventually extend past trades training and be integrated into several aspects of the school. While we currently maintain several post secondary partnerships within Black Gold through the Dual Credit program, our main post secondary collaboration for the Collegiate is Northern Lakes College.

Celebrations & Challenges:

Celebrations

- Calmar received a renovation that was complete in 2017 and the building still impresses visiting individuals. This is a testament to the staff and students who treat the building with respect.
- There is a long history of excellence in trade training within the building. Upon first entering the building, one can see the banners from the machining program that celebrate student achievement in the Skills program at the Provincial and National levels.
- Several companies actively support our machining program namely Manluk Industries Inc.
- We have a very active drama and musical theater program that presents a play in the fall (this year is Beetlejuice) and participates in One Acts in the spring. The presentations are extremely well received in the fall and our students are often recognized at the One Act festival.
- The athletic program at the school works hard to support the students of the school and in some seasons this could mean up to six teams being run at a time. We are lucky to have several coaches on staff as well as in the community to support this endeavor.
- The school is currently receiving an addition to the structure in the form of a shop to support Collegiate training. We are pleased that this change has encouraged several partners to approach the school to provide support. Amongst others Northern Lake College and Building Trades of Alberta have been big supporters.
- Through diligent scheduling we have been able to limit the amount of combined classes that exist within our schedule.
- Our 5 year high school completion rate is high supporting a philosophy of lifelong learning and the need to create individualized timelines for students that are reflective of their needs.

Challenges

- We continue to see the after effects of the disruption in learning that took place between 2020 and 2022. Students are still adapting to being back in the classroom as well as the increased academic requirements that the classroom brings.
- Accessing Alberta Health services to support mental and physical health remains a concern as with other schools outside of the main centers. This concern is attached to both the ability to best understand the programs without being in the center and with our families having the resources to access support.
- While we are pleased to be entering into the Collegiate realm it does come with some consternation. These concerns surround the sustainability of a program that requires significant monetary input to support a consumable/tool intensive environment as well as an environment that requires instruction from ticketed instructors.
- As can be seen below in our Assurance Measures - Overall Summary, we have some areas of concern within our building. While the Assurance survey is a valuable resource we also completed a Rural Schools survey completed by a third party last year. While some parallels can be drawn between the surveys there are definite differences. The low turnout of respondents on the Assurance survey (9) as well as its limited scope (Grades 7 and 10) in some ways encourages the use of our Rural School data

Calmar Secondary School Council Annual Report 2023 - 2024

- In 2023/24 CSS Council met 7 times and discussed a variety of topics including creating a breakfast program, option classes, staffing/budget, ASCA grant, parking, in school presentations, Wellness Week activities, AERR, school calendar, Council of School Councils, Jasper Ski trip, introduction to Esports, created an online option for families to attend Council meetings, updates on the Collegiate school and a variety of other topics and concerns.
- At each meeting we had many parents in attendance, as well as our admin team consisting of Justin Klaassen, Dan Lake, Darcy Skinner and Karen Gartner, staff members Krista Reed, Becca Mudry and Danika May, as well as BGSD Trustee Devonna Klassen. Superintendent Bill Romanchuk and Assoc. Superintendent Ray Cable each made a guest appearance.
- We hosted a parent engagement evening using our ASCA Grant on March 7, 2024. Saffron came and presented to parents and staff "What happens when youth press send?"
- School Council chair attended 3 Council of School Council meetings through the year. Topics discussed included School Council annual reports, online guidance for councils and fundraising associations, ASCA grant ideas, approved operating procedures, bullying. It is a great time to connect with other school councils, Trustees as well as the Superintendent.
- School council members took part in surveys and gave feedback on: the assurance survey, the Alberta Education Results Report (AERR), Black Gold draft calendar survey, as well as a Rural School Survey.

- Moving forward, the Calmar Secondary School Council will continue to work with administration, staff and the board of trustees to support initiatives and provide volunteers whenever necessary to support our student's educational journeys. We will continue to inquire about all things related to education from our administration, the district and the province. We will encourage parental engagement at all levels and provide feedback to all stakeholders. We will continue to build our school community and to encourage open communication with all involved in our children's education.
